NIPER will not provide any fellowship to such candidates from its funds, however the student can claim from the original funding agency which selected them for fellowship. Please note that valid proofs of clearing the fellowship examinations are mandatory for appearing in the interview. The candidate should have good academic background in respective discipline and he/she should be self-motivated with an independent, target-oriented and systematic working style. A high degree of creativity and flexibility as well as excellent collaborative skills are desirable. No TA/DA or any other expenses will be paid for appearing in the interview.
