GUIDELINES AND SCHEDULES FOR THE ENTRY M.S.Pharm (BATCH 2020-22) STUDENTS

In the current Covid-19 Scenario the Institute allowing the entry of M.S. Pharm (Batch 2020-22) students in batches. The following are the key recommendations and guideline about the entry of students in the campus of NIPER-R.

- a) **Voluntary** entry of the students to the hostels is allowed in batches and a staggered manner.
- b) **Entry of the students, as per the notified schedule, is purely voluntary. In exercising the option of voluntary entry, the students must realise the risks and the responsibilities associated with the Covid-19 pandemic.**
- c) The student needs to provide undertakings/information as follows. (1) they will comply with the institute quarantine policies; (2) if the health officials recommend Covid-19 test at any point in time, the student agrees for the same to be performed on them; (3) at any point in time if there is need for further quarantine, the student agrees to comply with the requirement; (4) The student will provide current active contact phone no of local guardian/close relative/parents in case any need arises for the officials to contact them.
- d) All students arriving on the campus need to undergo a **07 days quarantine**. Students residing in Lucknow who wish to move to the hostel also need to fill-in the entry form and follow the schedule of entry provided.
- e) The student is required to provide a consent form from parents/relatives in case of a need arising for the student's hospitalization and expenses of Covid-19 test and treatment will be borne by self.
- f) Students will not be allowed to leave the campus without prior permission from hostel wardens. Permissions may be granted only in the cases of emergency.
- g) Students with any health issues/comorbidities/diabetics etc. are strongly encouraged to take care all necessary precaution prescribed.
- h) Students and personnel working in the departments are required to follow rules of social distancing, wearing mask and adhering to the guidelines issued by Govt. of India and NIPER-R.
- i) All students will have to undergo Covid-19 test after the self-isolation/quarantine is over and as when institute required. Those who test negative will be allowed re-entry into the labs. The Covid-19 test expenses will be borne by the students.
- j) The Institute will provide individual bed, table, chair and Amirah to all student. Incoming students should arrange their own mattresses/bed-roll and other personal requirements.
- k) All student should bring two (2) Tiffin boxes for providing food during quarantine period.
