1.0 Invitation of EOI:

National Institute of Pharmaceutical Education and Research, Raebareli (NIPER-R) is a National Institute in Pharmaceutical Sciences with a proclaimed objective of becoming Centre of excellence for advanced studies and research in Pharmaceutical Sciences.

In order to augment the NIPER R&D strength, a requirement is being felt in the Institute to procure the latest technology of **Measurement of Particle Size**, **Zeta Potential**, **Molecular Weight and Microheology** for research and educational purposes.

2.0 Schedule of requirement: The broad feature of the proposed instrument is as follow:

The purpose of the broad feature is to draw an outline of our requirement, on the basis of which the proposing firms shall conceive a solution for the NIPER-R and submit the EOI bid accordingly.

2.0 Eligibility Criteria/ Pre-qualification Requirement

- I. The Bidder should be a manufacturer who must have designed, manufactured, tested and supplied the equipment(s) similar to the type required in our Institute or a dealer exclusively authorized by the manufacturer to quote on their behalf for this bid or Indian agents of foreign principals.
- II. The bidder should have executed at least two similar orders successfully during the preceding three financial years at any NIPER/CSIR/ICAR/ICMR/DAE/DRDO/DST/DBT/IIT/Other Government or autonomous research Labs / Institution/ State Government undertaking in India.
- **III.** The bidder should have their own service support network in India preferably in Lucknow or New Delhi and should have a competent manpower to handle any technical issue arising

during warranty or post-warranty periods to ensure a continuous trouble-free operation of the equipment.

Note: No EMD is required for submission of this Expression of Interest bid.

5.0 Evaluation and Selection Criteria:

The EOIs submitted received from all the bidders shall be evaluated on the basis of the eligibility criteria outlined above. On the basis of this evaluation, the eligible bidders will be required to give a presentation on their product and the solution conceived by them for NIPER, Raebareli. The date for presentation will be from **23.01.2019 at 11.00 A.M onwards**.

On the basis of the presentations given by the eligible bidders and the Bidder Response Outline Sheet information provided by the bidder as per this document, the technical committee shall draw detail technical features and specification for the equipment keeping in view the requirement of NIPER and shortlist manufacturers/ firms accordingly. Only the shortlisted firms will be issued Request for Quotation (RFQ) and will be required to submit their Technocommercial and Financial bids by a specified date. After the bids are received from the shortlisted bidders, evaluation of the received bids will be done on the basis of the tendered specifications and the lowest evaluated responsive bidder (L1) shall be awarded the contract.
