Lucknow. High academic achievement with 1<sup>st</sup> class graduate and post-graduate examination with fulfillment of basic qualification.
- 4. Desirable skills:** Preference may be given to candidates with exposure to organic synthesis, characterization, and purification.
- 5. Age limit:** Maximum 28 years as of 1<sup>st</sup> April 2024 (age relaxation for SC/ST/PH is as per GoI rules).
