(Life sciences)/ Biotechnology, PG degree in other relevant branches of life sciences. High academic achievement with a 1st class graduate and post-graduate examination with fulfilment of basic qualification.
- **3. Desirable skills:** Preference may be for candidates with exposure to cell culture/histology/molecular biology and animal handling or other relevant experimental skills.
